MEMBERSHIP FEES & PAYMENT POLICY

Season 2026/2027

Purpose

Membership fees directly contribute towards the operation of the Club, including affiliation fees, facility hire, equipment, baseballs, coaching, insurance, maintenance, and the ongoing development of our junior, women's and senior programs.

Prompt payment of membership fees enables the Club to continue providing quality facilities, equipment and opportunities for all members.

*** Concession Membership is available to members who meet one of the following criteria:**

- Full-time students;
- FIFO workers whose work roster significantly limits their availability to participate throughout the season; or
- Age Pension recipients.

The Club may request reasonable evidence to confirm eligibility where required.

Please Note

- Baseball WA registration fees are payable separately at the time of registration.

Multiple Registration Discount

Members registering for more than one eligible playing membership will receive a **20% discount on the lower-value membership fee**. The discount applies to Club membership fees only and does not apply to Baseball WA registration fees unless otherwise determined by Baseball WA.

Registration

Membership is not considered complete until:

- the member has completed the required registration process;
- applicable Baseball WA registration fees have been paid; and
- One of the following has occurred:
 - Club membership fees have been paid in full; or
 - an approved payment plan has been entered into with the Club.

The Committee reserves the right to decline or defer registration where previous membership fees remain outstanding.

Payment Options

Members are encouraged to pay their membership fees in full at the time of registration.

Payment plans are available at the discretion of the Registrar and are intended to assist members experiencing genuine financial hardship.

Payment plans are:

- available by application only;
- subject to approval by the Registrar;
- intended for members experiencing genuine financial difficulty;
- a privilege, not an entitlement; and
- reviewed annually by the Committee.

All approved payment plans must be paid in full by **20 December 2026**.

Member Responsibilities

Members approved for a payment plan agree to:

- make all scheduled payments on time;
- notify the Registrar as soon as possible if circumstances change;
- maintain regular communication with the Club; and
- ensure all membership fees are paid in full by **20 December 2026**.

Membership Fee Compliance

To ensure fairness for all members, the following policy applies.

Outstanding fees after 20 December 2026

Any member with outstanding membership fees after **20 December 2026** will become **ineligible to participate in Club matches and Club-sanctioned activities** until their account has been paid in full.

A player will become eligible to resume participation immediately once all outstanding membership fees have been paid in full.

Future Payment Plan Eligibility

Members who fail to complete an approved payment plan by **20 December 2026** will not be eligible to access a payment plan during the following season.

Future payment plan requests will only be considered under exceptional circumstances at the discretion of the Committee.

Outstanding Fees from Previous Seasons

Members with outstanding membership fees from a previous season will not be permitted to register for a subsequent season until all outstanding fees have been paid in full, unless exceptional circumstances exist and approval has been granted by the Committee.

Annual Review

The payment plan program is offered in good faith to support members experiencing financial hardship.

Should the Club continue to experience significant unpaid membership fees, the Committee reserves the right to review, amend or discontinue the payment plan program in future seasons.
